Your site's source of water may need additional treatment processes added based on the specific water source(s) and results of water analysis. Our modular approach ensures that each treatment process unit required is tailored to the unique water source, quality, and water volume needs of that dwelling or small community.

The additional treatment processes include selective abstraction, pre-filtration screen for secondary water source, backwashable multimedia filters, granular activated carbon filters, water softener, iron and manganese removal, pH correction, and chlorination.
